1. Pledge of Allegiance

Mayor Sack called the meeting to order and invited the Council to join in the Pledge of Allegiance.

2. Roll Call

Mayor Sack asked the City Clerk to call the roll; a quorum was present to conduct official city business.

3. Recognition of the Rye Girls All Star Basketball Team

Mayor Sack congratulated the members of the Rye Recreation Girls All Star Basketball Team along with their coaches and Recreation Department supervisor on their victory in the 2015 Westchester County Girls Basketball Championship. The Mayor and Councilwoman Brett presented everyone with proclamations.

4. General Announcements by the Council

Announcements were made regarding various topics, events and meetings that may be of interest to residents.

5. Draft unapproved minutes of the special meeting of the City Council held March 9, 2015 and the regular meeting of the City Council held March 11, 2015

Councilwoman Brett made a motion, seconded by Councilman Mecca and unanimously carried, to approve the minutes of the special meeting of the City Council held on March 9, 2015, and the minutes of the regular meeting of the City Council held on March 11, 2015, as amended.

6. Issues Update/Old Business

Mayor Sack reported on the following topics:

Parking Pay Stations: The parking pay stations in the Central Business District now accept credit cards for charges of \$1 or more.

Sewer Discharge: The City has been violated for discharge into Long Island Sound from a pump station. City Manager Culross explained that when the sewage treatment plant reaches capacity, it comes back to the pump station and the pump station bypasses it to the Sound. The City is obligated under its SPEDES permit to self-report. There was a discussion regarding how illegal sump pumps connected into the sanitary sewer system contribute to overflows and ways to rectify the situation.

Hen Island: The Mayor said the Council is still considering the issues on Hen Island but offered his preliminary feedback. Conditions on the island are rustic but idyllic. There was no mosquito infestation the day that members of the Council visited the island. The Mayor said that the cottages on the island are seasonal and are not dwellings under the definitions of the New York State Building Code. Most camp sites have biodegradable toilets, which will probably work for all the cottages based on the seasonal definition. Even though the potable water collection basins had not all been covered in the past, most seem to be covered now. The Building Department has been out to the island recently and there are no open violations. Councilwoman Brett said that although some of the conditions on Hen Island would not be acceptable on the main land, people making changes to the temporary cottages are currently doing so in accordance with the City Code. Councilwoman Killian said that there is a New York State campground statute that they are bound by which is different from other building codes.

Brian Dempsey: A resident has raised concerns regarding Mr. Dempsey serving on the Traffic and Pedestrian Safety Commission because the traffic engineering consulting firm he works for has done work for the City. The Mayor said the City is grateful for its volunteers and for the expertise that Mr. Dempsey brings to an advisory committee. Mr. Dempsey had previously requested an opinion from the Ethics Committee, who opined that disclosure was important. Councilman Slack said it was important to identify conflicts. He noted that the Council and members of City staff fill out conflict of interest forms at the beginning of the year and suggested the Council should further discuss the previous decision by the Council a few years ago of not asking members of Boards and Commission to file these forms.

Harris Beach: Mayor Sack said that Corporation Counsel Wilson is a counsel at the firm of Harris Beach who represents the City in several matters. Some of the matters are covered under the Retainer Agreement; some by specific retention beyond the Retainer Agreement and some as a result of being retained by the insurance company, not by the City. Ms. Wilson was asked to provide a list of cases that Harris Beach is handling and to indicate if they are being handled under the Retainer Agreement, by retention by the Council or by the insurance company.

7. Continuation of Public Hearing to amend local law Chapter 165, “Signs”, of the Rye City Code by adding Section §165-10, “Regulation of banners”, to establish regulation for banners on City owned ball field fences and utility poles on City property

Councilman Slack asked if Section A of the proposed legislation could be revised to reflect what was previously decided by the Council regarding banners on ball fields so the Council can deal with Section B involving banners on utility poles. Corporation Counsel Wilson said the proposed local law reflected additions to the Sign legislation, and she could revise the local law to remove Section A. Mr. Slack said he did not believe there was a great interest in banners in the downtown and suggested that legislation could simply provide that banners on poles in the downtown were not allowed except with express approval of the Council. Other members of the Council agreed with this proposal.

Councilwoman Brett made a motion, seconded by Councilman Slack and unanimously carried, to adjourn the public hearing to the April 8, 2015 meeting.

8. Consideration to set a Public Hearing for April 8, 2015 to amend local law Chapter 177, “Taxation”, Article XII, “Exemption for Historic Districts” by adding Section §177-82, “Historic Districts, to designate portions of downtown Rye as one historic district to allow property owners to apply for the real property tax exemption

Councilwoman Brett said the Landmarks Committee is proposing designation of the City’s first historic district in order for property owners in the district to be able to apply for a tax incentive that phases in tax increases on historic properties that are renovated or rehabilitated rather than torn down in order to encourage adaptive reuse. Councilman Slack raised questions for discussion during the public hearing regarding the large size of the proposed district and how it was determined; whether it was appropriate for discretion on whether properties in this large proposed historic district be given to the Landmarks Committee, which is an advisory committee; whether it is possible to look back ten years to see what renovations have been done in the proposed district to obtain some estimate of the amount of the tax breaks that could be expected over the next ten years if this law was enacted; and the definitions of “alteration” and “rehabilitation” in the City and State codes and how they cross-reference and would be applied in practice.

Councilwoman Brett made a motion, seconded by Councilwoman Killian and unanimously carried to adopt the following Resolution:

WHEREAS, the Council wishes to consider amending Chapter 177 “Taxation”, Article XII “Exemption for Historic Districts” of the Code of the City of Rye by adding a new Section 177-82 “Designation of Historic Districts”; and

WHEREAS, it is now desired to call a public hearing on such proposed amendments to the law, now, therefore, be it

RESOLVED, by the Council of the City of Rye as follows:

Section 1. Pursuant to Section 20 of the Municipal Home Rule Law and the Charter of the City of Rye, New York, a public hearing will be held by the Council of said City on April 22, 2015 at 7:30 P.M. at City Hall, Boston Post Road, in said City, for the purpose of affording interested persons an opportunity to be heard concerning such proposed local law.

Section 2. Such notice of public hearing shall be in substantially the following form:

9. Presentation by Sustainable Westchester, Inc. regarding the City of Rye participating in the program Community Choice Aggregation to procure electric and/or gas supply services on behalf of participating residents, businesses and municipal customers within municipal jurisdictional boundaries

Mike Gordon representing Sustainable Westchester made a presentation about the Community Choice Aggregation (CCA) program. He said there are two components on everyone’s electric bill – (1) the transmittal and distribution portion which is the cost for Con Edison to deliver electricity across the poles and wires it owns; and (2) the energy portion, which represents the costs associated with purchasing energy from power plants. Con Edison is the default supplier of energy for people in New York who do not choose a separate competitive Energy Supply Company (ESCO). Sustainable Westchester petitioned the Public Service

Commission to allow the implementation of a CCA in Westchester County, without touching the poles and wires that are controlled by Con Edison. The request was granted in February. There is now an opportunity for municipalities in Westchester to participate in the CCA to purchase energy. Customers who have not already chosen another ESCO will be given the opportunity to opt out, but if they do not, they become a member of the CCA and receive its benefits. The City Council would vote on whether to join the CCA, which will be managed by Sustainable Westchester. Bids will be sent out to all competitive energy service providers in New York for both variable rates and fixed rates. There is no guarantee that the rates will be lower than those charged by Con Edison.

Members of the Council asked questions regarding how often the CCA would go out to bid for rates and who would be included; the mechanics of people opting out and getting back in; how a homeowner would know if they were saving money; who would be contacted in the case of a power outage; whether the City was being put in the position of being a marketing agent for the CCA; what the administrative costs of the CAA program would be; whether it is legal for a town board to pass a resolution to join the CAA or if it would have to be done by voter referendum; and what taxes would still be collected.

Mayor Sack asked Mr. Gordon to advise the Corporation Counsel when an opinion is issued by the Solicitor General's Office regarding the requirement for a referendum so the Council can decide how the issue would come back before the Council.

10. Residents may be heard on matters for Council consideration that do not appear on the agenda

11. Resolution authorizing the Corporation Counsel to seek settlement in the litigation *American Leisure Activities of New York City Inc. v. City of Rye*
Roll Call

Corporation Counsel Wilson said this is a breach of contract case dealing with the lifeguard contract for the 2013 summer season at Rye Golf Club. Both sides were awarded summary judgment with the question of damages remaining. After a meeting before the Judge in the case, the parties agreed on a settlement of \$30,000 subject to Council approval. Ms. Wilson said that the firm of Harris Beach is defending the City in this case on an hourly basis and because it is a breach of contract claim, insurance coverage has been denied.

Leon Sculti, Chair of the Golf Commission, raised questions regarding fees that may be the responsibility of the Golf Club Enterprise Fund. He requested a joint meeting between the City Council and the Golf Commission. Councilman Slack pointed out that the Golf Club is owned by all the citizens of Rye and not just the members of the club. He added that the Enterprise Fund is simply an accounting tool. Councilwoman Bucci said she would commit to getting numbers to the Golf Commission regarding what is knowable. City Manager Culross said that it was important for the Golf Commission to be part of the annual CIP process. Mayor Sack agreed to meet with the members of the Golf Commission.

Councilwoman Brett made a motion, seconded by Councilman Slack, to adopt the following Resolution:

RESOLVED, that the City Council of the City of Rye, hereby authorizes the Corporation Counsel to seek settlement in the litigation *American Leisure Activities of New York City Inc. v. City of Rye* in the amount of \$30,000.

12A Resolution to amend the 2015 Adopted Fees and Charges for the Rye Golf Club Enterprise Fund

Councilwoman Bucci outlined the proposed changes which include allowing seniors to come to the pool from Monday through Thursday at a cost of \$5 per day if they are a member of the Rye Recreation Senior Program and a Young Executive Membership program to target golf members between the ages of 27 and 35. Leon Sculti, Chair of the Golf Commission, said the Young Executive Membership program is a pilot program that will be limited to 20 members.

Councilwoman Bucci made a motion, seconded by Councilman Slack, to adopt the following Resolution:

RESOLVED, that the 2015 Adopted Fees and Charges for the Rye Golf Club Enterprise Fund are hereby amended to add the following new programs:

Pilot Program for Seniors who are currently members of the Rye Recreation Senior Program to allow them to visit the Rye Golf Club pool once per week on a Monday through Thursday (not including Memorial Day or Labor Day) for a daily access fee of \$5.

Pilot Program establishing a limited “Young Executive” membership category for individuals between the age of 27 and 35. Up to 20 new memberships at the rates of \$2,100 for Residents and \$3,920 for non-residents.

Mayor Sack said that he believed the best way to continue the momentum from the Deer Summit held last month was to establish an Ad Hoc Temporary Committee to help frame the issues.

Mayor Sack made a motion, seconded by Councilwoman Brett and unanimously carried to adopt the following Resolution:

**RESOLUTION OF THE CITY OF RYE ESTABLISHING
A TEMPORARY DEER MANAGEMENT STUDY GROUP**

WHEREAS, the Rye City Council convened a Deer Management Summit at Rye City Hall on February 25, 2015, in conjunction with the Village of Mamaroneck; and

WHEREAS, the purpose of the summit was to articulate the problems caused by the increasing over-population of deer in our community and the wider Sound Shore area, including

the degrading of our eco-system, the spread of Lyme disease, and the increased danger of automobile accidents; and

WHEREAS, the purpose of the summit was also to consider options in addressing this problem and to identify the most feasible, efficient, and cost-effective solutions; and

WHEREAS, the representatives from the New York State Department of Environmental Conservation and the County of Westchester were in attendance at the summit to offer their expertise and perspective; and

WHEREAS, this is an issue of great concern among members of the Rye community and throughout the region; and

WHEREAS, the Council desires to establish a Deer Management Study Group, to assist in continuing the dialogue in our City coming out of the summit, and to help focus the Council on any decision points as we move forward; now therefore

BE IT RESOLVED, that the Rye City Council hereby establishes a temporary Deer Management Study Group to study such matters and to report back to the Council from time to time over the course of the next year; and

BE IT RESOLVED, that the members of this study group shall be appointed by the Mayor.

Mayor Sack appointed Janice Seitz, Ed Collins and Anne Dooley to serve on the Temporary Deer Management Study Group

BACKGROUND: Council is asked to consider amendments to Chapter 165, "Signs" of the Rye City Code to allow for the display of banners on utility poles on City property.

See attached Draft Local Law.

CITY OF RYE

LOCAL LAW NO. 2015

A local law to amend Chapter 165 “Signs” of the Code of the City of Rye by adding a new §165-10 to establish the process by which banners can be placed on City owned utility poles located on City property and to renumber the remaining section of the Chapter as follows:

Section 1: Chapter 165, Signs.

§ 165-10. Banners on City owned utility poles.

A. Banners are permitted on City utility poles in the Central Business District upon receipt of a license from the City Council.

- (1) All banners to be placed on the utility poles shall be approximately 30” by 60”.**
- (2) Banners supporting a community purpose or function shall be considered by the City Council.**
- (3) When reviewing applications, the City Council shall take into consideration the design and colors of the banners to ensure that such are appropriate for display in the Central Business District.**
- (4) The City Council shall consider applications for banners on a first come/first serve basis and shall discretion over how long banners may be displayed depending on the demand for space, the length of time the advertised event will be occurring, the time of year (e.g. seasonal signs), and any other reasonable circumstances surrounding the request.**
- (5) The City Council may place reasonable conditions on any license as part of its approval.**
- (6) No establishment may be granted a license for an activity or event within 90 days of the expiration of the establishment’s previous license for an activity or event sign.**

B. Once a licensed is issued, the licensee is required to provide the banner(s) to the Department of Public Works for display. The City shall display and remove all banners.

C. The license fee(s) shall be set annually by resolution of the City Council.

§ 165-101. Severability.

If any phrase, sentence, part, section, subsection, or other portion of this chapter or any application thereof to any person or circumstance is declared void, unconstitutional or invalid for any reason, then such word, phrase, sentence, part, section, subsection or other portion, or the proscribed application thereof, shall be severable, and the remaining provisions of this chapter, an all applications thereof, not having been declared void, unconstitutional or invalid, shall remain in full force and effect.

Section 2: This local law will take effect immediately on filing in the office of the Secretary of State.

BACKGROUND: In January, the City Council adopted a resolution requesting HIF grant assistance from Westchester County to fund a \$1 Million sewer line extending from an existing connection in Nursery Lane to a new connection near the intersection of North Street and Summit Avenue. The sewer relocation project is necessary and required by the City Council in its November 2014 zoning district change to advance the construction of a 40-unit affordable housing rental development for seniors for a Westchester County-owned property at 150 North Street. The existing sewer line extends under I-95, through the 150 North Street property to an existing connection in Theodore Fremd Avenue. The existing sewer line serves the High Street/Maple Avenue/Central Avenue neighborhood and goes to the Blind Brook Sewer District. The proposed new sewer line would require the transfer of 113 properties (shown in green on the attached map) from the Blind Brook Sewer District to the Mamaroneck Valley Sewer District. The attached resolution is required since the transfer of properties from sewer districts requires approval from the County Board of Legislators.

The proposed project would abandon the existing sewer line under I-95, which requires increasingly frequent City maintenance that is difficult to access and service. Property owners in the affected area would experience improved sewer service. The estimated increase in sewer district tax for the Mamaroneck Valley district would be less than three dollars annually.

WHEREAS, the General Fund Contingent Account has a balance of \$300,000, now therefore be it;

RESOLVED, that the Deputy City Comptroller is authorized to transfer \$250,000 from the General Fund Contingent Account to the Public Works Department.

BACKGROUND: Due to the timing, intensity, and number of storms during the 2015 winter season, the funds apportioned for the purchase of salt and overtime related to storms and snow removal expenditures exceeded the allocation in the adopted 2015 budget.
