**SETTLEMENTS**

In June I notified you that a notice of claim had been filed by Scott Steele claiming that a fence and trees on his property had been damaged with a City tree fell on them during a storm. Our insurance company has denied the claim because the tree fell due to the weather.

**LITIGATION**

**BEAVER SWAMP BROOK – (DEC Administrative proceeding)**

A response was received from the ALJ this week in connection with this matter and is being reviewed.

**BASSETT v. CITY OF RYE**

Judge Berliner (the trial court judge) is still considering the post trial motions and no decisions have been rendered.

**CASPI v. CITY OF RYE**

The discovery deadline has been extended to October 31, 2011. A conference in this matter is scheduled for October 27, 2011.

**R.B. CONWAY V. CITY OF RYE**

The trial has been calendared for September 2011.

**DELLI PAOLI V. ZONING BOARD OF APPEALS**

The Board of Appeals reaffirmed the Board of Architectural Review's decision to deny the application at their May meeting.

**SHEW v. CITY OF RYE**

Plaintiff has filed a reply memorandum of law with supporting affidavits in further support of Paul Shew's motion to file a late amended notice of claim.

**MOLLOY v. PLANNING COMMISSION**

Appellants have submitted a motion to enlarge their time to file their appellate brief from the Appellate Division, Second Department. No decision has been rendered. If the request is granted, the new date would be September 5, 2011.

**PANETTA v. PLANNING COMMISSION**

This matter is now fully submitted in Supreme Court, Westchester County.

MUNDINGER v. PLANNING COMMISSION
