Upon applying to receive an Off-Leash Dog Permit from the City of Rye for Rye Town Park, I understand and acknowledge the following:

- The Rye Town Park Dog Park is not supervised, nor fenced in.
- Being physically present at the dog park necessarily involves risk of injury to me and my dog(s) from other dogs.
- Being physically present at the dog park necessarily involves risk of injury to other people or dogs from my dog(s).
- Dogs may act unreasonably or unpredictably.
- Dogs may be infected with diseases and/or parasites which might infect me or my dog(s).

I hereby expressly assume all risks involved in participation at the Dog Park.

I hereby agree to defend and indemnify the City of Rye, its agents, assigns, and employees from all claims and lawsuits arising from dog bites, attacks, or any other claims arising from the Rye Town Park Off-Leash Dog Park. This indemnification includes claims arising from my own acts or omissions, or that of other dog owners/ handlers.

I hereby release the City of Rye, its agents, assigns and employees from all injuries that I and/ or my dog sustain in the Dog Park as a result of the acts or omissions of other dog owners/ handlers or the actions of their dog(s) in the Dog Park.

I have read, understood and agree to the terms and conditions of this Acknowledgment, Agreement, and Release and expressly assume the risks of participating at the Rye Town Park Dog Park.

I agree to abide by all rules and regulations of the Dog Park, and always carry my permit with me when using the park.

RYE TOWN PARK – RULES AND REGULATIONS

The Rye City Council has amended Chapter 76 “Dogs” of the Rye City Code in order to allow dog owners, who have registered for a permit with the Rye City Clerk’s Office, to let their dogs off their leashes in a specified area of Rye Town Park during the hours of 6:00 a.m. to 9:00 a.m. Dogs must be leashed at all other times.

In order to receive the permit, dog owners must complete an application and provide proof that their dog is licensed and up to date on their rabies shots. In addition to the permit, which must be carried at all times when in the park, the owner will receive a tag that must be attached to the dog’s collar.

Regulations are as follows:

- Dogs may be off leash between the hours of 6:00 a.m. and 9:00 a.m.
- All dogs must be licensed, current with all shots & healthy. **Proof of rabies vaccination certificate is required.**
- Anyone wishing to allow his/her dog to be off leash in Rye Town Park must register with the Rye City Clerk.
- Any dog off leash must have a registration tag affixed to his/her collar.
- Dog owners must carry the Rye Town Park Permit at all times when in the park.
- The maximum number of dogs that any one person shall have custody and control over is three.
- Dog owners must clean up after their dogs.
- Owners must not leave dogs unattended and shall have dogs under voice control at all times.
- Owners are legally responsible for their dogs and any injuries caused by them.
- Dogs must be discouraged from digging – Owners must fill any holes their dogs dig.
- Aggressive dogs are not permitted.

The permit will be renewable every year for a fee of **\$30.00**. Application forms can be downloaded from the Permits and Forms section of the City of Rye website (www.ryeny.gov). If you have any question, please contact the City Clerk’s Office (914) 967-7371 during regular business hours.
